Extra information and consent slip

The Research School Network (RSN) was set up by and is managed by the Education Endowment Foundation (EEF). They are the data controller responsible for the production of the recordings described in this consent form.

How will the films be collected?

The GLA will collect and edit the film clips. All our films will be observational, capturing children's learning in settings/schools which sometimes capture their faces. They can include both children and educators who are present on filming day. Children are sometimes referred to by their first name in the videos when participating in the filming session.

How will the films be used and stored?

The videos will be stored on a password-protected storage space with restrict access. A member of the Gloucestershire Research School team will edit the collected clips. Gloucestershire Research School and their partners will embed the videos in training slides and share them via training. They will not be posted on websites, youtube or social media platforms.

The edited clips will be retained for as long as the resource they are produced for remains in use. The unedited film will only be stored for as long as required to produce the final clips for the online resource.

The EEF is an independent charity dedicated to breaking the link between family income and educational achievement. They do this by supporting schools and early years settings to improve teaching and learning through better use of research evidence to inform the decisions they make. The Research School Network is an integral part of this mission by leading the way in the use of evidence-based practice.
